Session Outline

The purpose of this session is to explore with delegates how blogs can be used in student assessment. Drawing on two case studies where students blog as one part of their assessment, this session will consider the practicalities of blogging for students. In particular, the session will focus on the benefits that students can derive from blogging, particularly with respect to reflection. It will also offer practical advice on how to get students started; potential problems and pitfalls to avoid, for students, self and institution and how to maintain student interest throughout the blogging period.
